## Minutes of the Admission cum Prospectus Committee meeting held on 13<sup>th</sup> August, 2021

The meeting was chaired by the Academic Registrar, Bodoland University. The House after discussion adopted the following Resolutions.

**Resolution No. 1:** The house after prolonged discussion decided to create a new University portal by service provider/technical party. The Academic Registrar is advised to make an arrangement for demonstration to be participated by the interested party /service provider on 16<sup>th</sup> August, 2021.

Resolution No. 2: Discussed and decided that on line forms will be scrutinized by the department concerned.

**Resolution No. 3:** It is decided to start the Application Registration process through online mode from 15<sup>th</sup> September, 2021.

**Resolution No. 4:** Entrance test will be conducted from 17<sup>th</sup> September to 20<sup>th</sup> September, 2021. Common Entrance Test programme is to be published by the Academic branch.

**Resolution No. 5:** Fifty percent weitage will be on merit and fifty percent weitage will be on the Marks of the Entrance test. In case there is tie then Career profile would be considered for promotion.

**Resolution No. 6:** Entrance test will carry 50 marks and Time allotment will be one hour and thirty minutes for the entrance test.

Resolution No. 7: Question pattern will be determined by the concerned department and submit the same in the Academic branch for it notifications.

Resolution No. 8: Merit list will be declared on 25th September, 2021.

Resolution No. 9: Intake capacity of department concerned will remain the same to the original intake capacity followed during the Academic Session 2019-2020.

**Resolution No. 10:** Reservation policy of Govt. of Assam and reservations permitted by Bodoland University authority will be followed as per rule.
