

Minutes of the Admission Committee meeting held on 18th August 2017

A meeting of the Admission Committee of B.U. was held on 18th August, 2017 at 1:00 p m in the conference hall of Administrative Building B.U. The meeting was presided by the Hon'ble Registrar of B.U. The purpose of the meeting was to discuss regarding present status of admission held in various Departments under Bodoland University. The House discussed on various agenda of the meeting and adopted the following resolutions:

Resolution No: 1. Today's House discussed regarding the Vice Chancellor's discretionary quota and Governor's order thereafter the house decided that Admission Committee will not be responsible for admitting students under Vice Chancellor's discretionary quota and Governor's order. The list has been prepared by Hon'ble Vice Chancellor whereas the Governor has asked to examine only to provide seats to tea & ex-tea students and accordingly, Hon'ble Vice Chancellor has prepared the list of students to be admitted. On the other hand, the house came to know that Hon'ble Vice Chancellor's preparation list against Hon'ble Governor's order that some students have not even submitted the application forms in the Departments. As such their names would be summarily rejected.

Resolution No: 2. The House discussed regarding the present status of admission held in various Departments and after discussion the HoDs explained one by one present status of the respective Departments. Out of intake capacity there is to accommodate for additional admission 85 (Eighty five) nos of candidates recommended by the Hon'ble Chief of BTC. Regarding that HoD of Physics stated that already 20 seats and 2 seats V.C. Quota has been admitted and accordingly the practical Laboratory/rooms are not available to allocate students. HoD of Zoology, Botany stated that single classroom has been shared for taking class and practical room even can't allocate 10 extra students even teaching faculties are also not available as the waiting candidates came everyday for admission. HoD of Political Science explained that class rooms are small and there are no sufficient benches and desks. Indeed it is very difficult to take conduct classes. The HoD further suggested that the waiting list students may be upgraded against the absent seats as they are having high percentage. HoD of Economics has stated that seats are filled up and out of filled up seats 7 seats are vacant. HoD of English stated that 0% attendance students may be cancelled and against absent seats the seats may be provided from waiting list. The HoD of Education stated that 6 admitted students have been absent. The HoD of Bodo has stated that 6 admitted students have 0% attendance. The HoD of Chemistry has stated that 6 admitted seats are vacant and hence the HoD suggested that 6 seats will be upgraded from waiting list. The HoD of Assamese suggested to upgrade from waiting list. The HoD of Biotechnology stated for the 2nd phase waiting list preparation and also suggested to admit the absent seats.

Under the above circumstances, Hon'ble Registrar suggested to accommodate by examining properly by looking the instructions and by providing audio-visual facilities. Finally, the House kept pending on the admission of Hon'ble Chief of BTC recommendation for admission until the next Admission Committee meeting as the Hon'ble Vice Chancellor is absent in the meeting. The Hon'ble Registrar as chairman is not empowered to take decision as he is only empowered to chair the meeting.

The meeting came to end with thanks from the chair.
