## Minutes of the meeting with Deans & Heads held on 30th April, 2019

A meeting with Deans and Heads of Bodoland University was held on 30<sup>th</sup> April, 2019 at 2:00 p. m. in the conference hall of Administrative Building of B.U. The meeting was presided over by Hon'ble Vice-Chancellor of Bodoland University. The purpose of the meeting was to discuss regarding the process of admission to be held in various departments under Bodoland University for the session 2019-2020. The House discussed on various agenda of the meeting and adopted the following resolutions unanimously:

Resolution No: 1. The house resolved that applicant's application forms shall be obtained from the University website or prospectus purchased from the office of Bodoland University. Dully filled in forms along with necessary testimonials should be submitted off line to the respective departments by hand or post on time. Prospectus fees Rs. 500/- (Five hundred only) and Entrance Test fee Rs. 300/- (Three hundred only) have been fixed.

Resolution No: 2. 80% reservation of seats for admission from Bodoland University affiliated colleges and BTAD areas and 20% reservation of seats from outside have been decided to follow.

Resolution No: 3. 40% from entrance test and 60% from academic merit would lead to selection of the candidates for admission.

Resolution No: 4. Total marks for entrance would be 50 marks with duration of two hours.

Resolution No: 5. If candidates from Bodoland University affiliated colleges of BTAD areas would not be available, then candidates from non-BTAD and outside would be selected with same quota.

Resolution No: 6. The House resolved to constitute Prospectus Committee for the session 2019-2020.

Resolution No: 8. The house resolved that admission for fee-waiver shall take place like previous year when there would be Govt. notification. Admission fees however, would be collected from the students at present and reimbursed after receipt of the fund.

**Resolution No: 9.** A phone diary with phone numbers and email ids of all employees of the University would be printed by the authority.

Resolution No: 10. The dates of admission, time & venue would be mentioned department-wise in the prospectus. No candidate would be permitted to take admission after due date and time.

Resolution No: 11. The minimum gap period for any Diploma and B.Sc. Bamboo Studies would be followed as per University rules.
