

**Minutes of General Meeting of Academic Matters held on 4<sup>th</sup> April, 2018.**

A general meeting of the academic matters at Bodoland University was held on 4<sup>th</sup> April, 2018 at 1:00 PM in the conference hall of Administrative Building, Bodoland University.
