
The following guidelines are to be followed in conduct of Practical Examinations and Evaluation of Dissertation/Project Report:

1. All Practical Examinations are to be conducted as per the programme notified by concerned College.
2. External Examiners from the University departments or other colleges affiliated to Bodoland University may be appointed by Principal and the copy of the appointment letter(s) is/are to be forwarded to the office of the Controller of Examinations. However, external examiner may be appointed/invited from institutions affiliated to other Universities in case of non availability for concerned paper/subject within colleges/university departments under BU.
3. Question paper is to be prepared by external examiner in consultation with the internal examiner of the concerned subject/paper of the college. In this regard, Internal Examiner is directed to share the syllabus and other related information with the External Examiner.
4. The Question papers of the Practical Examinations are to be submitted to the office of Controller of Examinations after the finish of Practical Examinations.
5. Last date of submission of Practical marks/Dissertation is **24<sup>th</sup> December, 2022**
6. Answer scripts of Practical examinations are to be submitted to the office of CoE, BU. You are hereby requested to comply with the above guidelines for conducting Practical examinations or Evaluation of Dissertation/Project report. Further, all examinations are to be conducted adhering to latest SOP for Covid 19 issued by Govt. of Assam.
