Eligibility of bidders and General Instructions:

Sl No General Instructions:

- Due Date: The tender has to be submitted on or before the last date. Quotations received after the last date and time will not be considered.
- Preparation of Bid: The offer/bid should be submitted in single bid systems (i.e.)
 Technical bid and financial bid both together. The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should

indicate item wise price for the items mentioned in the technical bid.

- Opening of the tender: The Quotations will be opened by the Tender Opening committee in presence of bidder's representative if available. Only one representative will be allowed to participate in the tender opening. Bid received without Application Fee's will be rejected straight way. The technical bid will be examined by a technical expert.
- Acceptance/ Rejection of bids: The University reserves the right to reject any or all offers without assigning any reason. The University may adopt other criteria for disqualification of a bidder as it may consider appropriate. Such Criteria may include the following: -
 - a) Failure of any Bidder (s) to provide all of the information /documents required in the bid proposal or any additional information /documents as sought by the University including supporting documents.
 - b) Non receipt of Bid proposal on or before due date and time
 - c) Misrepresentation in the Bid proposal
 - d) Non Payment of Tender Fee

5 **Pre-qualification criteria:**

- (i) Bidders should be the manufacturer / authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) on the same and specific to the tender should be enclosed.
- (ii) An undertaking from the OEM is required stating that they would facilitate the bidder on a regular basis with technology/product updates and extend support for the warranty as well.
- (iii) Non-compliance of tender terms, non-submission of required documents, lack of clarity of the specifications, contradiction between bidder specification and supporting documents etc. may lead to rejection of the bid.
- (iv) In the tender, either the Indian agent on behalf of the Principal/OEM or Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender. If an agent submits bid on behalf of the Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM in the same tender for the same item/product.
- (v) Tenderer Should have registered in Assam and trading experience since last 3-4 Years.
- (vi) Bidder should have Experience of executing at least 2 (Two) Single work order of similar nature in any Indian Universities / National Eductional Institution.
- (vii) The bidder should quote for all the items in the tender as a package only. The comparative statement will be made as a package only. Bidder who doesn't quote for all the items as per the given Tender Specifications are subject to be disqualified.
- (viii) Bidder are requested to check the existing CCTV System before bidding so that it can be installed in line with existing system.
- **Delivery:** Delivery of the goods should be made within a maximum of **7days** from the date of receiving the Purchase Order.
- Delayed delivery: If the delivery is not made within the due date for any reason, the University will have the right to impose penalty 2% per week and the maximum deduction is 10% of the contract value / price.
- 8 **Prices**: The price should be quoted in net per unit (after breakup) and must include all packing and delivery charges. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account

- 9 **Inspection and Tests:** Inspection and tests prior to shipment of Goods and at final acceptance are as follows:
 - The acceptance test will be conducted by the Purchaser, their consultant or other such person nominated by the University at its option after the equipment is installed at purchaser's site in the presence of Bidder's representatives. The acceptance will involve trouble free operation and ascertaining conformity with the ordered specifications and quality. There shall not be any additional charges for carrying out acceptance test. No malfunction, partial or complete failure of any part of the equipment is expected to occur. The Bidder shall maintain necessary log in respect of the result of the test to establish to the entire satisfaction of the Purchaser, the successful completion of the test specified.
 - In the event of the ordered item failing to pass the acceptance test, a period not exceeding one weeks will be given to rectify the defects and clear the acceptance test, failing which the University reserve the right to get the equipment replaced by the Bidder at no extra cost to the Purchaser.

Successful conduct and conclusion of the acceptance test for the installed goods and equipment shall also be the responsibility and at the cost of the Bidder.

- Right to Use Defective Goods: If after delivery, acceptance and installation and within the guarantee and warranty period, the operation or use of the goods proves to be unsatisfactory, the University shall have the right to continue to operate or use such goods until rectifications of defects, errors or omissions by repair or by partial or complete replacement is made without interfering with the Purchaser's operation.
- Installation, Training and Demonstration: The Bidder is required to do the installation, provide training and demonstration to the designated Purchaser's technical and end user personnel to enable them to effectively operate the total equipment.
- 12 **Incidental services:** The incidental services also include:
 - Furnishing of 01 set of detailed operations & maintenance manual.
 - Furnishing of Software Cd's if available with the equipment's.
 - Arranging the shifting/moving of the item within BU premises at the cost of Bidder through their representatives.

Warranty:

- Warranty period shall be for **12 Months** from date of installation of Goods at the BU Campus. The Bidder shall, in addition, comply with the performance and/or consumption guarantees specified under the contract. If for reasons attributable to the Bidder, these guarantees are not attained in whole or in part, the Bidder shall at its discretion make such changes, modifications, and/or additions to the Goods or any part thereof as may be necessary in order to attain the contractual guarantees specified in the Contract at its own cost and expense and to carry out further performance tests. The warranty should be comprehensive on site.
 - The University shall promptly notify the Bidder in writing of any claims arising

under this warranty. Upon receipt of such notice, the Bidder shall immediately within 07 days arrange to repair or replace the defective goods or parts thereof free of cost at the ultimate destination. The Bidder shall take over the replaced parts/goods at the time of their replacement. No claim whatsoever shall lie on the University for the replaced parts/goods thereafter. The period for correction of defects in the warranty period is 07 days. If the Bidder having been notified fails to remedy the defects within 07 days, the University may proceed to take such remedial action as may be necessary, at the Bidder's risk and expenses and without prejudice to any other rights, which the University may have against the Bidder under the contract.

- The warranty period should be clearly mentioned. The comprehensive warranty will commence from the date of the satisfactory installation/commissioning of the equipment against the defect of any manufacturing, workmanship and poor quality of the components.
- 14 **Governing Language**: The contract shall be written in English language. English language version of the Contract shall govern its interpretation. All correspondence and other documents pertaining to the Contract, which are exchanged by the parties, shall be written in the same language.
- Payment: 100% payment shall be made by the University against delivery, inspection, successful installation, commissioning and acceptance of the equipment at University in good condition and to the entire satisfaction of the University.
- 16 **User list:** Brochure detailing technical specifications and performance, list of industrial and educational establishments where the items enquired have been supplied must be provided.
- Safety Precaution during execution of work: The party shall take all safety precautions during the execution of works and shall ensure that no part of the building shall be damaged. The necessary crack repairing work in the wall surface including making necessary groove, applying putty or filling sealant powder, wherever required shall be carried out by the party and nothing extra shall be paid for the same.
- Application Specialist: The Bidder should mention in the Techno-Commercial bid the availability and names of Application Specialist and Service Engineers in the nearest regional office.
- 19 **Application Fees:** An amount of Rs. 1,000/- should be deposited in the Bodoland University Account No. 31607155480, IFSC Code- SBIN0007379 by online mode as tender fee (non-refundable).
