#### Terms and Conditions of Supply:

- 1. Original Aquarium Manufacturers / Dealers/ Authority Supplier/ Individuals having minimum experience of 3 years in aquarium supply. The intending bidder should have never made any default in supplying / Maintenance of Aquariums Authority / Semi Authority/ Central or State Public sector enterprise(s) for any reasons in the last five years.
- 1. The last date and time for the acceptance of the bids is 20/01/2023 up-to 12:00 noon.
- 2. Suppliers should be submitted the following documents along with their quotations:
