#### **ELIGIBILITY CRITERIA:-**

- (i) The bidders shall have having valid Electrical License issued from PWD (E)/APDCL.
- (ii) Satisfactory completion of at least one similar works each of value not less than Rs. 20.00 lakhs or two similar works each of value not less than Rs. 10.00 lakhs (year ending March, 2023).
- (iii) Similar work shall mean works of supply, installation, fitting and fixing of electrification work and earthen work etc.
- (iv) The bidders should have average annual financial turnover of Rs. 50.00 lakhs.
- (v) The firm should have valid registration for service tax GST and should have Permanent Account Number (PAN).
- (vi) The bidders should have ESIC (Employees' State Insurance Corporation), PF certificate and valid labour license.
- (vii) The bidders shall submit a solvency certificate for an amount of Rs. 20.00 Lakhs from a bank.
- (viii) IT Returns for the last three consecutive financial years ended on March 31, 2022 audited by CA.
- (ix) The bidders should furnish copies of work orders and completion certificates from the clients in support of the above.

#### **TERMS AND CONDITIONS:**

- 1. The work must be guaranteed for a period of 12 months for its satisfactory performance from the date of completion and all defects cropping up within this period must be rectified at contractor's cost immediately at own cost.
- 2. Rates shall be quoted in both figures and words. Rate quoted in original Tender will be considered.
- 3. No Tender will be accepted after the stipulated date and time as mentioned.
- 4. The proposed work be increased as per need of this office and no payment will not be considered against incomplete work and found not satisfactory by this office.
- 5. The undersigned reserves the right to accept any or to reject any or all the Tender/Tender without assigning any reasons whatsoever and he does not bind himself to accept the lowest Tender.
- 6. All taxes including GST, duties, cess, levies, royalty, transportation cost, packaging cost, delivery cost, loading-unloading cost or any other tax on material etc. required in connection with the work/supply payable by the Tendered under the contract, or for any other cause shall be included in the rates, prices submitted by the Tendered. No extra amount will be borne by the Department.
- CONDITIONALTENDERS OR INCOMPLETE TENDERS ARE LIABLE FOR REJECTION.
- 8. Each page of the tender shall be signed by the authorized person and cutting or overwriting should be treated as cancelled.
- 9. The renderers shall quote their rates for individual items both in words and figures; in case of discrepancy between the rate quoted in words and figures, the unit rate quoted in words shall prevail. If no rate is quoted for a particular item, the tender will be liable for rejection.

#### 10. EXTENSION OF TIME:

In case if the entire Electrical work is not able to complete within the given period. The Contractor shall apply for extension at least 15 days before the expiry of the period of completion.

## 11. GUARANTEE (for Electrical Portion of work)

- a). The Electrical work carried out shall be guaranteed against manufacturing defects and/or workmanship and for its satisfactory performance for a period of 12 months from the date of commissioning. Necessary warranty certificate obtained from manufacturer for the material supplied by contractor shall be submitted to University at the time of commissioning.
- b). The all fitting and fixing items shall be warranted for a minimum period of 12 months by the manufacturer. Necessary certificates shall be handed over to University by the contractor.
- c). During the course of guarantee period, in case any defect is noticed due to faulty workmanship or defective materials used, necessary repair has to be arranged to the entire satisfaction of the University and such works will be carried out at contractor's risk & cost.
- d). The bidders shall **strictly furnish** aforesaid information in the formats/schedules given. **Non adherence to furnishing of information in the given format/schedules given will lead to disqualification of tender.**
- e). Each page of the application shall be signed by a person having necessary authority to do so.

## 12. ACCIDENT, SAFETY OF MEN AND MATERIAL

- a). The contractor shall be fully responsible for ensuring safety at all times and shall bear the cost of all damages in cases of accidents/ unusual occurrences resulting in damages to University property.
- b). The contractor must ensure the safety of laborers engaged by him while handling the materials/transporting the materials from one place to other places during the course of execution of Electrical work and the University will not be responsible for any injury sustained by the laborer or any fatal accident and the contractor should bear all the loss and expenditure involved.
- c). The Contractor shall take all precautionary measures not only for protection of his own personnel moving about or working on the University premises, but also confirms to the rules and regulations of the Universities in this respect.

#### 13. QUALITY OF ELECTRICAL WORK

- a). All Electrical work shall be carried out to the entire satisfaction of the University.
- b). All materials used in the execution of the contract shall conform to the Indian Standard Specifications and be of the best quality and of the class most suited for the purpose specified.
- c). The contractor shall ensure that the equipments & services under the scope of this contract whether manufactured or performed with in the Contractors premises or at his subordinates premises or at the University site or at any other places also strictly in accordance with the provisions of this contract. For this purpose, the contractor shall adopt necessary quality assurance programmed to control such activities at all stages.
- d). If any item found technically and quality wise unacceptable by the Registrar, University reserves the right to reject and require free replacement provision with technical and quality is better item.

## 14. The Tenderers will have to furnish the following with the bid:

- i) Court-Fee stamp of Rs.10.00.
- ii) Copy of Electrical License issued from having valid Electrical License issued from PWD (E)/APDCL.
- iii) The no Power of Attorney will be accepted.
- iv) The receipt of tender fee and EMD deposit should be submitted along with the bid.
- v) Copy of PAN.
- vi) Copy of GST registration.
- vii) Copy of up-to-date Trade License
- viii) Undertaking regarding not blacklisted.
- ix) The Firm/Contractor should have ESIC (employees' State Insurance Corporation) and PF certificate.

#### 15. RIGHT TO ACCEPTANCE / REJECTION OF TENDER:

- a). The right of acceptance of Tender rests with the authority of University who does not bind itself to accept the lowest Tender and also reserve the right to reject any or all the Tender(s) received without assigning any reason whatsoever. Any dispute arises in future will be finalized by the Jurisdiction of Kokrajhar Court.
- b). Tenders imposing any extra conditions of their own will not be entertained.
- c). No price escalation will be granted.

#### 16. AWARD OFCONTRACT:

- a) After fulfillment of criteria in the evaluation process and approval from competent authority the notification of award i.e., L.O.A.(Letter of Acceptance) will be issued in favor of selected supplier for supply at approved rates. However, lowest evaluated price shall not be the sole criteria for award of contract.
- b) Within 15 (fifteen) days of receipt of the notification of award i.e., L.O.A, on signing the agreement and submission of Performance Security Deposit@ 5% by the selected tenderer, the Authority of B.U. will award the contract to the selected quotioners.
- c) On acceptance of the Bid, the Bidder shall name in writing his accredited representative(s), who would be responsible for taking instructions from the Department.
- d) On submission of the Performance Security Deposit by the successful bidder, the EMD/Bid Security will be returned to him by the authority.

#### 17. PENALTIES FOR DELAYED SERVICES:

Penalty: The firm shall rectify any breakdown within 24hours failing which penalty for non performance @0.5% per week of delay subject to a maximum of 10% of the contract price will be imposed and in the

event of any damage to the property or life arising out of non performance, contractor will be solely responsible.

The Authority of University reserves the right to cancel the order in case the delay is more than 4 weeks. Penalties, if any, will be deducted from the Security Deposit.

#### 18. PAYMENT PROVISION:

No advance payment will be made at any circumstances. However, payment will be released within a reasonable period from the date of receipt of the bills along with certified copies of monthly service reports, log sheets, work done as per the scope of work mentioned in the tender/contract duly certified by the concerned in-charge. Contractor will submit monthly/quarterly bills duly supported with necessary check list, log sheets monthly service reports duly signed by the concerned in charge and certified by the designated officer to the effect that the job mentioned in the bill actually has been carried out satisfactorily as per the contract. Thereafter, the undersigned will make payment to the contractor within a reasonable period after deduction of applicable taxes/ TDS etc.
