## **RULES AND REGULATIONS FOR BUSU ELECTION 2024**

Under the directives of the Hon'ble Supreme Court of India and Lyngdoh Committee Report, the BUSU Election Commission is empowered to hold election for the Students' Union of the University. The Election Commission shall select suitable candidates for posts that are uncontested. For elections to be valid there must be at least two candidates for a post. In the event of there being only one candidate, the election for the post concerned shall be deemed cancelled and the Election Commission, in such event, shall appoint / select suitable candidate for such post.

- 1. He/ She must be a student of 1<sup>st</sup>, 3rd or 5<sup>th</sup> Semester classes of both UG and PG.
- 2. He/ She and his/her proposer and supporter must be regular in attending classes, having not less than 75% of class attendance. One proposer and one supporter can propose and support one candidate only.
- 3. Although, the committee would refrain from prescribing any particular minimum marks to be attained by the candidate, the candidate should in no event have any academic arrears in the year of contesting the election.
- 4. He/ She must be certified by the Head of the Department as having cordial relationship with the Departmental teachers and office staff. The certificate should show that the candidate is good at study and bears a good moral character.
- 5. He/ She must not have any liability both in the Department and Office.
- 6. He/ She must have mission to work for the welfare of the students of the university and for the development of the academic affairs.
- 7. The maximum age limit to legitimately contest the election would be 25 years for PG and UG students between 17 and 22 years.
- 8. The candidates shall not have a previous criminal record or misdemeanor. The candidates must not have been subject to any disciplinary action by the University authority.
- 9. The maximum permitted expenditure per candidate shall be Rs. 5,000/-. Each candidate shall, within two weeks of declaration of the result, submit complete and audited accounts to the University authority.
- 10. The candidates are barred from utilizing funds from political parties and any other sources except voluntary contributions from own pockets.
- 11. All candidates are prohibited from indulging in corrupt practices and offences.
- 12. Canvassing or propaganda within 100 meters of polling station is restricted.
- 13. Printed posters/pamphlets/banners/ materials are not allowed for canvassing except only hand-made posters. Wall writing/Wall pasting of posters etc. are restricted failing which the candidature would be cancelled.
- 14. No candidate is permitted to carry out processions /public meetings/any way of canvass outside the University campus.
- 15. Destruction to any property of the University would lead to severe punishment on the candidates.
- 16. The use of loudspeakers, vehicles and animals for the purpose of canvassing is prohibited.
- 17. The voters shall carry valid proof of identity to the polling booth with I. Card /Admission Receipt.
- 18. One candidate can appoint only one polling agent at the time of voting and counting the ballot papers.
- 19. Any candidate/ student would impart his/her grievances to the Grievances Redressal Cell for preventive measures.
- 20. Incomplete application shall be summarily rejected and the decision of the Committee for BUSU Electoral College shall stand final for any matter related to Students' Union Election of the University.
- 21. Swachhta should be maintained in the entire election process, students must take part in cleaning programme soon after the completion of election process.
- 22. Students desirous of contesting BUSU Election shall obtain the forms from the Accounts Section by paying Rs. 100/- per form and deposit Rs. 700/- as Nomination Fee.
