It is for general information to the economically poor students of Bodoland University that the students willing to apply for financial assistance under Poor Students Aid Scheme of the University may apply in the prescribed proforma as enclosed. The last date for submission of application is 22<sup>nd</sup> May, 2025. The financial assistance will be provided to 100 poor students of the University or on the availability of fund. The decision of Poor Aid Fund Committee shall be final in all matters including criteria of selection.

**Note:**

- i. The financial aid will be admissible to the PG second year students (3<sup>rd</sup> and 4<sup>th</sup> semester) whose parent's annual income does not exceed Rs. 150000.00.
- ii. A current certificate of annual income from all sources of parents issued by local Circle Officer.
- iii. Self Attested Photo copies of University renewal admission receipt.
- iv. Final year graduation certificate has to be submitted along with PG first and second semester passing grade card.
- v. The scheme shall be applicable to PG Second year University Students fulfilling the above criteria.
- vi. The Committee will adopt any criteria for selecting the applicant.
- vii. An amount of Rs. 5000 per student will be allocated to the 100 selected applicants or on the availability of fund.
- viii. The awardees will be selected provisionally. After verification of documents the same will be finalized for award of the aid.
- ix. The final selection of candidate will be done by the committee. The decision of the committee is final in the matter.
