It will be conducted for provisionally selected candidates (based on performance in online test, screening and interview) before joining the Bank, Candidate who fails to qualify this test will not be offered appointment. Candidates who produce 10° or 12° standard mark sheet/ certificate evidencing having studied the specified opted local language of the applied Circle as one of the subjects will not be required to undergo the language test.
