**Approval of Admission procedure of PG Programme for the session 2019-20**

The Admission Committee of the University under the Chairmanship of Hon'ble Vice-Chancellor has prepared Guidelines/General Procedure for Admission into PG Programmes under BU and accordingly the prospectus has been prepared for the session 2019-20. In this regard, the House is requested to consider the matter for the formal execution.

**Resolution No. 2**

**After threadbare discussion on the admission of PG Programme for the session 2019-20, the House resolved that 80% seats be reserved for the students of Colleges under BTAD area and 20% seats for the colleges of other Universities. Further, it is also resolved that within 80% reservation of seats 20% be reserved for affiliated degree colleges under BU and 60% for non-affiliated degree colleges of BTAD area on merit plus entrance basis.**

In compliance with UGC Notification, Bodoland University has already implemented CBCS System in the Under Graduate Course from 2015 in its affiliated Degree Colleges which was prepared by the Board of Studies. Moreover, as per Resolution No. 1 of First PG Board meeting held on 12<sup>th</sup> June, 2015, the meeting has also decided to implement the CBCS (Choice Based Credit System) in the PG Course of the University. Accordingly, the concerned department has prepared PG Syllabus in CBCS pattern for implementation. Therefore, the House is requested to examine the syllabus accordingly and approve the same for execution.

**Agenda Item No. 9****Discussion regarding Study Leave for teachers**

Some teachers have applied for Study Leave and as per provision of the UGC Gazette Notification, 2018 (Amended) Clause 8.2 (i, ii, iii, iv, v, vi) stated that the scheme of Study Leave provides an opportunity to avail of scholarship/fellowships awarded to the faculty who wish to acquire new knowledge and to improve analytical skills, as the study leave shall be granted not more than twice during one's entire career and leave shall not be granted for more than three years in one spell, save in exceptional cases, in which the Executive Council is satisfied that such extension is unavoidable on academic grounds and necessary in the interest of the University. However, the maximum period of study leave admissible during the entire service shall not exceed five years. The House may discuss on the granting of study leave to the faculties of Bodoland University as per UGC Rules.

The House widely discussed on the granting of study leave to the faculties of Bodoland University and resolved that Study Leave would be granted as per the rules of the University Grants Commission notified from time to time.

**Agenda Item No.10****Discussion regarding Students Grievances relating to Examinations.**

Three Post Graduate Students of the University have submitted application for appearing in the 2<sup>nd</sup> and 4<sup>th</sup> Semester PG Examinations. It is to be mentioned that applicants have already appeared examination for three times which is maximum permissible limit as per PG Examination Regulations (Clause No. 11.5). Moreover, one PG Student from Zoology department has also submitted an application for obtaining grace mark due to completion of three attempts. Hence, the matters may be discussed in the house for further necessary action.

**Resolution No. 10**

The House thoroughly discussed regarding the grievances of the students for appearing in the 2<sup>nd</sup> and 4<sup>th</sup> Semester PG Examinations and also obtaining of grace mark to some students, as these students have already appeared examination for three times which is maximum permissible limit as per PG Examination Regulations (Clause No. 11.5). In this regard, the House decided to constitute a Committee through office file including a member from outside the University to examine the feasibility of addressing the students' grievances for appearing the examinations.

**Agenda Item No.11****Discussion regarding the memorandum submitted by the Bodoland University Alumni Association (BUAA)**

The Bodoland University Alumni Association submitted a memorandum to the university authority regarding reservation of 50 % of seats in admission for ex students (alumni) of this university in M. Phil and Ph. D. programme. They have stated that there has been some sizable number of pass out students from the Bodoland University who are looking for the further studies and opportunities in research work. It is stated that some of the Alumni have acquired only few seats in various universities and institutes within India. There are also many students who have not been able to pursue further studies in other universities or institutions because of financial problems and lack of opportunities. Moreover, they have also stated that reservation policy of fifty percent for alma-mater (Ex-students) may be considered with a view to facilitating our own students for further studies/research works. The students who make through merits in M. Phil and Ph.D. programme may be excluded from reservation category, whereas they may be considered as merit candidate only. The house may think over the matter.

**Resolution No. 11**

The meeting minutely discussed on the memorandum submitted by the Bodoland University Alumni Association (BUAA) for the reservation of 50% seats for ex-students in the M. Phil & Ph.D. admission under Bodoland University and forwarded the matter to the Research Council for the proper analysis and mechanism to implement the demands of Alumni Association of BU.

**Agenda Item No. 15****Discussion regarding Co-supervisor**

Srivastava, Associate Professor, Department of Physics, Central Institute of Technology, Kokrajhar has applied for allowing him as Co-supervisor in the Department of Physics of Bodoland University. It is stated that a provision for Co-supervision from the local institution particularly from the CIT, Kokrajhar may be allowed, as both the institutions are adjacent to each other. Such initiative will facilitate a good platform between two premier institutions of BTAD in order to enhance research activity as well as research credential of the University, which usually requires for NAAC accreditation. The MOU between CIT and BU is under process. The members are requested to approve the same.
