



Syllabus of M.Phil. Course Work 2016

Course Structure:

- The course work shall have four papers.
- The course work shall have two compulsory papers.
- The course shall have one optional paper to be selected from three optional papers by the candidate.
- The fourth paper shall be in the form of “Paper Submission and Presentation” in the department as Seminar.
- Each paper shall carry 5 Credits and 100 marks; which includes 20 marks for internal assessment and 80 marks for final term examination (except for the fourth paper).
- Candidates shall have to secure minimum of 50% in aggregate to clear the course work.
- Candidates shall be required to attend minimum of 75% of the total class days of the course work to appear for the final term exam.
- Candidate has to complete the whole process i. e. course work, synopsis presentation and Dissertation submission within 18 months (6 months for course work and 12 months for the preparation and presentation of the Dissertation).
- Every candidate has to submit Progress Report after every 6 months.
