COURSE OUTCOME:

- 1. Course Code 501: Research Methodology
- **CO-1:** After completion of this course, students will have a basic foundation on Scientific Research.
- **CO-2:** Give knowledge base on the systematic approaches to do research in political science and its allied fields.
- **CO-3:** Help to search for new paradigm and multiple issues in Political Science for research.
- **CO-4:** Demonstrate knowledge of research process i.e. reading, evaluating and developing.
- **CO-5:** Perform literature reviews using print and online database.
- **CO-6:** Identify, explain, compare, and prepare the key elements of a research proposal or a research report.

2. Course Code 502: Computer Applications

CO-1: The course is to teach the basic computational skills and provide scholars with the means to learn what they need to know for their research.

CO-2: Teaching the elementary programming techniques applicable in social science research.

CO-3: Writing reusable, interpretable code

CO-4: Problem-solving - debugging programs for errors.

CO-5: Obtaining, importing, and munging data from a variety of sources

3. Course Code 503: An Introduction to Political Science

CO-1: Upon completion of this course, students will have an idea about the basics of Political Science who come from other disciplines as research is inter-disciplinary in its nature.

CO-2: Analysing what is Politics and Political Science and explaining the approaches to the Study of Political Science – Normative, Behavioural, and Post Behavioural.

CO-3: Develop familiarity with both Political Science as an independent area of academic study and research and inter-disciplinary nature of it.

CO-4: Understanding basic concepts of Rights, Liberty, Equality, Justice and Citizenship that may help in theorizing the research as a whole, and related to the research topic in specific.

CO-5: Gives an overview on power as a central area of study in Political Science and its relationship with authority, legitimacy and political obligation.

CO-6: Classification of Democratic Theories and its application with critical analysis.

CO-7: Contemporary debate on Civil Society and its role as a-political group and to do research on it.

CO-8: Explaining the concept of Nationalism, State and Sovereignty with critical analysis of its changing role in the context of Globalisation.

CO-9: An overview on the traditional ideologies in political science with its development in the contemporary period.

CO-10: It focuses on contemporary ideologies, like- ecologism, feminism, multiculturalism, identity politics, social movements, and human rights etc., based on human values that may enable students for further research on new paradigm of a dynamic society and its structure and issues.

4. Course Code 504A: Women, Gender and Feminist Research

CO-1: This course gives an overview of feminist research from theoretical and empirical point of view.

CO-2: Introduces the students with the term gender studies and different key concepts related to it.

CO-3: Gives an idea on patriarchal structure of society and its implications in multiple aspects of life.

CO-4: Develop familiarity with women's studies and research as an academic discipline and its importance, scope and challenges.

CO-5: Understanding feminism and feminist theories with contemporary feminist debates.

C0-6: Introduces the students with feminist epistemology, feminist standpoint and principles of feminist research.

CO-7: Develop an idea of feminist research methodologies with the application of unique tools and techniques and approaches to data collection.

CO-8: Enable students to build up proper research design and theorization applicable for feminist research.

CO-9: Issue of Sexuality and other Intersections.

CO-10: Open up the areas for research in gender studies and women's studies, like- women empowerment and development; women and health; gender based violence; gender, culture and media; gender and religion; female leadership; women, law and governance etc.

5. Course Code 504 B: Politics of North East India

CO-1: It aims at expanding the horizons of research and teaching on North East India. The following will be the main course outcome of the paper.

CO-2: It aims at a holistic understanding of the region by bringing together different epistemic perspectives with a strong commitment to multi-disciplinary research on various issues related to North East India. The researcher will be able to understand the sociopolitical and cultural aspects of the region.

CO-3: To bring the region to the centre of national discourses, the syllabus aims to focus on issues relating to NE India such as Migration, Demographic Transformation, Ethnic Conflicts, Insurgency, Identity Politics, Underdevelopment and Unemployment, Tribal Rights and Environmental Issues.

CO-4: It also focuses on areas of research, such as social change, religion and statecraft, empowerment politics, regional economic growth, livelihood studies, border trade and state policies, global capital and institutions, conflict, peace and security studies, borderland studies, intercultural discourses, aesthetics and performance studies, traditional knowledge, health, bio-diversity, folk medicine, etc.
